I am writing to confirm the interment service on Wednesday, January 5, 2022 at 1:00 PM arranged through Cornell Memorial.

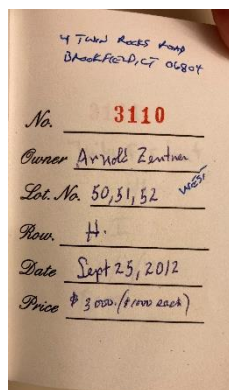
